## Abstract Diversity and Inclusion

The aim of the Equality SIG is to foster the combination of Research Integrity and Equality training for undergraduate and postgraduate curricula. Still little is discussed on the equality issues within Research Integrity and there could many issues such as racial discrimination, gender and intersectional issues, sextortion, etc. We hope to start a conversation on how to best meet these goals (promoting a dicussion on equality issues in Research Integrity and then how to train it) in Brussels during the NERQ kick-off meeting, building upon the methods and collection of FORRT's lesson plans. FORRT—the Framework for Open and Reproducible Research Training (http://forrt.org/)—an interdisciplinary community of 500+ early career scholars aiming to integrate open science principles into higher education and advance research transparency, reproducibility, rigor, and ethics through pedagogical reform, especially when aligned with principles of justice, equity, diversity, inclusion and accessibility.
